He is very much focused and dedicated to the growth, empowerment, and character formation of the students. One of his students is working at NASA today. He commented that his involvement and achievement in the profession are due to the experience gained during

his studies at St. Xavier's College of Education, Palayamkottai. Rev. Fr. Provincial thanked God for this wonderful guidance of the institution. Further, he thanked all the faculties and requested to continue the journey towards the formation of values, character building, and skills among the students. With those words of appreciation, the Chairman led the group into the agenda of the meeting. As the minutes of the previous Governing Body was already sent to thee-mails of the members for their perusal, it was approved by the members of Governing Body with a small modification.
