The General Guidelines and the Composition of the Appeals and Grievances Redressal Cell

- a) The dissatisfaction or disagreements of the students in any form which is against the court of law, Disciplinary Regulations (Cfr. Tamilnadu Educational Rules (1973) Nos. 93-98), ethos and good manners and behaviours; of the fellow students, faculty and supportive staff members could be brought to the notice of the college.
- b) The students are insisted to make use of the Complaint Box near the main notice Board (Off Line) and the separate link <http://grivance.sxcedn.edu.in> in which is in our college website to lodge their grievances and appeals.
- c) The identity of the student will be kept confidential.
- d) Within 15 days, the complaints will be enquired by the Appeals and Grievances Redressal Cell or the steps would be taken to resolve it.
